1 KNOW ALL MEN BY THESE PRESENTS: That the UNITED STATES FIDELITY

18 ing and enjoining the Respondents and/or Defendants from segregating
19 persons and pupils in the Elementary Schools of Respondents and/or Defen-
20 dants districts, and that

21 WHEREAS, Respondents and/or Defendants have filed Notice of Appeal
22 therefrom to the Circuit Court of Appeals for the Ninth Circuit, and
23 are appealing therefrom.

24 NOW, THEREFORE, if the said Respondents and/or Defendants who shall
25 later be termed Appellants, shall pay the costs if the Appeal is dis-
26 missed or the judgment affirmed, or such costs as the Appellate Court
27 may award if the judgment is modified, then this obligation is to be
28 void, otherwise to remain in full force and effect.
